

Southern Maryland Blue Crabs “Catch that Ball” Sweepstakes Official Rules.

NO PURCHASE NECESSARY TO ENTER OR WIN.

Purchasing Tickets or Merchandise Will Not Increase Your Chances of Winning.

Eligibility: Sweepstakes (“Sweepstakes”) is open to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older (or of legal age of majority in their state of residence, whichever is older) as of date of entry. Employees, officers and directors of Opening Day Partners and its affiliates (the “Clubs”) and their immediate family members (parent, spouse, sibling, or child) are not eligible to participate or win.

1.) The Clubs, as applicable, reserve the right, in their sole discretion, to void any and all entries of an entrant who the Clubs, as applicable, believe has attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes or who is otherwise not in compliance with these Official Rules. The first randomly selected potential winner that answers a telephone call placed by the Clubs notifying him/her of his/her potential winning status will be declared the Prize winner, subject to verification of eligibility and compliance with the terms of these Official Rules.
